#### INTERNATIONAL STUDENTS (7-DAY BOARDER):

\$50,000

This covers tuition, room and board.

A non-refundable \$5,000 registration fee is due before an I-20 will be issued.

The tuition rate for international students receiving the I-20 or F1 student visa from St. Mary's Preparatory is \$50,000 for tuition, and room and board. We provide a high level of administrative service, staffing, and when possible, language liaisons for international families/students thus causing the tuition and fee rate to be higher than for domestic students.

## REGISTRATION DEPOSIT (NON-REFUNDABLE): \$1,500 for all 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> & 12<sup>th</sup> grade students (due online during enrollment)

Other fees may include an \$100 parking fee (where applicable) and a \$175 pay-to-play fee (per sport).

In addition to the tuition and fees listed above, all students will be responsible for books, school uniform and various supplies from the bookstore. Estimated cost for these items is between \$500 and \$800 per Academic Year.

All families are also required to purchase \$500 in raffle tickets payable to St. Mary's Preparatory. Raffle tickets will be distributed in the Fall. Complete Raffle rules and requirements will be posted on the OLSM website prior to the distribution of tickets. Tickets and payments are due Monday, November 3, 2025. All payments not turned in by that date will be billed through FACTS on Monday, November 17, 2025.

Families will receive a \$1,000 "Family" discount for each student enrolled after the first student.

# FACTS PAYMENT PLAN (REVISED: JANUARY 2024)

St. Mary's has contracted with **FACTS** to manage tuition collection for the 2025-2026 school year. Enrollment in FACTS is *mandatory* for every family. Families may choose to pay their tuition in full or make semi-annual, quarterly, or monthly payments through **FACTS**. Families may either select the 1<sup>st</sup> or the 15<sup>th</sup> as their payment due date. St. Mary's will assess a \$40 late fee to all payments not made on the due date you selected (1<sup>st</sup> or 15<sup>th</sup>). Families may choose to be sent invoices from **FACTS** or they may sign up for automatic deductions from a specified bank account, or charges to a specified credit card. Payment in full must be completed by July 15, 2025.

To set up your **FACTS** agreement, watch for an invite from **FACTS**. Payment arrangements through **FACTS** must be completed when you receive the invitation from **FACTS**. The earlier payment is begun, the smaller the monthly installments will be. A large down payment may be made to reduce the monthly cost.

Any family that pays in full by June 1, 2025, is granted a \$100 discount off the price of tuition.

Any family with more than one student enrolled at the same time will receive a \$1,000 discount on each student after the first.

All families, whether they choose to pay in full or make monthly payments, are asked to make a non-refundable registration deposit towards tuition when they register for the new school year.

No student will be allowed to begin taking classes without submitting the properly completed Registration and Health Forms online, paying the registration deposit, and enrolling in FACTS.

### FINANCIAL AID

- St. Mary's Preparatory offers financial aid based on need, only.
- Partial Academic Scholarships are available to incoming 9<sup>th</sup> graders only.
- Financial aid is awarded on a first come, first served basis. Applying early greatly increases the chance of receiving an award.
- Applications for **new students** must be completed online at <u>www.sssbynais.org</u>. Our school code is 6830. You may start applying November 1<sup>st</sup>. Students who apply by January 1<sup>st</sup> will receive a decision in their acceptance packet. Those applying after January 1<sup>st</sup> must contact Admissions.
- St. Mary's Preparatory may not honor requests made after May 1, 2025.
- Students who applied for financial aid for the 2024-25 school year must fill out a Financial Aid Renewal Form found under Financial Aid-Returning Families at this link: <a href="www.stmarysprep.com/tuition">www.stmarysprep.com/tuition</a>. - The deadline to re-apply for financial aid is March 1, 2025. **This is a FIRM DEADLINE**.
- Financial aid does not cover books, school supplies, or fees.
- The balance owed must be resolved through the payment plan outlined above.
